TERM & CONDITION

- 1. The Internet service provider (ISP) must be registered in India as Limited company/Sole proprietorship under relevant acts.
- 2. Installation should be completed within 10 days after issuing of work order.
- 3. Installation and commissioning charge will be paid after successful installation and recurring charge will be paid quarterly after receiving of invoice.
- 4. The Contract will have a validity of one year from the date of installation & subscription.
- 5. Minimum 3 years past performance from Govt. organization should be attached with bid documents.
- 6. ISPs should have local office in Odisha and nearby service centre at Nayagarh.
- 7. The service shall be provided 24x7 days in a week. The ISP should have own manpower & technical team for support in Nayagarh for any down time.
- 8. The response time for attending the fault will be one hour after they are reported. The ISP will rectify the faults within 12 hours, failing which, the ISP will make temporary arrangement.
- 9. Minimum 8 nos. of IP to be provided for Internet service.
- 10. Bidders/ISPs have to submit last 3 years IT returns.
- 11. Bidders/ISPs have to arrange repair and maintenance for above contract period.
- 12. Bid value above 5 lakhs will not be considered.
- 13. The rate quoted for complete installation of internet should be competitive and all detailed component, if any required, to be mentioned clearly with specific rates and GST there on.
- 14. If the service will be found unsatisfactory, the contract of ISP will be terminated and same service will be provided to second deserved ISP.
- 15. All the disputes will be subjected to the jurisdiction of Nayagarh District.
